# SECTION 4. FIRST AID MEASURES

Eyes: Flush with plenty of water, especially under eyelids. Get medical attention if irritation persists.

# SECTION 5. FIRE FIGHTING MEASURES

**Suitable (and unsuitable) extinguishing media:** Use water, foam and ABC powder. Do not use carbon dioxide. This product burns with difficulty.

**Specific hazards arising from the chemical:** Solid product will burn slowly under fire conditions. Avoid generating dust. Fine dust dispersed in air in sufficient concentrations and in the presence of an ignition source is a potential dust explosion hazard. Thermal decomposition can yield carbon monoxide, carbon dioxide, hydrogen fluoride, perfluoroisobutene, hexafluoropropene and tetrafluoroethylene.

**Special Fire Fighting Procedures:** Fight as any normal fire using self-contained breathing apparatus (SCBA) and full protective clothing where exposed to smoke.
